## Wild About Nature Day Camp-4-Kids Child Participant 2009 Waiver Form

Woodland Presentations retains the right to refuse or dismiss any participant from camp. Disruptive or belligerent behaviour including bullying will not be tolerated for the safety and enjoyment of other participating children.

The parent or legal guardian is responsible for any excessive damage to equipment/displays caused by a participant. (“Excessive” means intentional damage sustained during a camp session – accidents and normal wear will occur and do not fall under this responsibility).

Please ensure that your children understand that they must remain with Woodland Presentations personnel at all times and not leave the premise without appropriate permission, for any reason. We will not allow a child to leave with another person other than the parent or guardian who dropped the child off unless written permission and information is provided to us at time of drop off. Until Woodland Presentation’s personnel becomes familiar with a participant’s parent or assigned guardian(s), parents or guardians will be asked to show Woodland Presentations personnel two pieces of acceptable identification prior to picking up a camp participant. Changes in pick up person will not be accepted by phone—a new contact sheet will have to be completed.

We do not conduct any hazardous activity nor will we ever place a child in a situation that threatens his or her safety; however, children can hurt themselves and others accidentally or through play as in everyday life. I, Diane Bourdon (camp owner & operator), am certified by Ready 4 Rescue and The Red Cross in basic First Aid/CPR/AED level B.

You, the parent or legal guardian, agree that there is always a risk of injury when children participate in camp and play together and therefore waive and release any right of claim for damages of any sort against Woodland Presentations, its personnel, and the camp facility’s owner in connection your child’s/children’s participation in this camp.
